SCHOOL FEES 2013

At a meeting of parents held on 8 October 2012, it was agreed that the fees for the 2013 year be set at R15050 per learner.

1. PAYMENT TERMS

Grade 8 – Grade 11 R1505 per month for 10 months (Jan-Oct)

Grade 12 R2150 per month for 7 months (Jan-Jul)

Payable as follows:

1st payment due by:

Grade 8 – Orientation Day on 11 *January 2013*

Grade 9-12 – *1st day of school 16 January 2013*
thereafter

Grade 8 – Grade 11 9 monthly payments from 28 February to 31 October

Grade 12 6 monthly payments from 28 February to 31 July

2. FAMILY DISCOUNT

If you have more than one child at The Settlers High and if your fees are up to date at the beginning of the year, you may deduct an amount of R440 per child from your 1st payment in January. If your fees fall into arrears during the year, this discount will be reversed and become payable.

3. EARLY SETTLEMENT DISCOUNT

R750 per child may be deducted if the fees are paid in full by 28 February 2013.

4. 1ST PAYMENTS (due on 1st day of school)

If paying by cash or cheque, please include the payment in an envelope with your child's name on it and send it with your child to class. It will be collected by the class educator during the 1st period and sent to the accounts office for receipting. If you wish to pay electronically, our bank details are as follows:

5. ADVANCE PAYMENTS

Payments toward fees for 2013 may be made in advance. This can help alleviate the financial outlay in January.

6. GENERAL

- The Governing Body takes a strict stance on arrear fees and all outstanding accounts will be handed over to attorneys for collection. Interest will be charged on overdue accounts at a rate of prime +4%.
- Learners whose fees are not up to date will not be allowed to take part in "extras" such as tours, camps, dances, grade functions, matric top etc.
- Financial assistance is available to parents who qualify according to the criteria and regulations set out in the SA Schools Act. Further information can be obtained from Mrs. Honing in the accounts office.
- If you have a debit order in force for 2012, we require you to complete a new debit order for 2013 if you wish to continue using this method of payment.
